

STUDENT HORSES ON COLLEGE FARM

1. Students must receive permission from the Equine Teacher **BEFORE** horses are brought to the farm.
2. Students are responsible for the care of horses at all times including weekends. When a student is absent from school (e.g. Closed weekend) they must discuss alternative arrangements in **ADVANCE**. These details must be confirmed with the Equine Teacher. Students **MUST** arrange for their horses to be temporarily removed from the farm for all term breaks (excluding long weekends).
3. Students must ensure that animals are properly cared for; animals must be checked **DAILY**. The **sole** and **total** responsibility for the care and management of students' horses on the farm rests with the student owners.
4. The sum of **\$15.00 per week agistment** will be charged for horses. Students are to provide **ALL** feed requirements. The college is only able to sell hay to students in an emergency.
5. Parents must give written permission for the students to ride horses and provide assurance that the students are reasonably proficient and expert riders. (See Horse Sign-Off Sheet)
6. Student's horses must be kept paddock that is allocated by the Equine Teacher at all times. Failure to do this may result in the horse being sent home. If a change is required, you **MUST** speak to the Equine Teacher.
7. The horse must be wormed within 7 before coming to the college. If the horse has been wormed recently, please advise.
8. At the end of each term, the paddock allocated to your horse **MUST** be cleaned free from old hay and manure. It is not fair for someone else to clean your horses mess.
9. Permission must be given by Hostel Supervisors **EACH** time horses are to be ridden with students giving details of duration and area where horses are to be ridden. (See Horse Riding Policy)
10. A helmet, boots, long trousers and long sleeved shirt must be worn when riding.

11. In signing this contract, you give consent to have the horse attended to by a vet, if deemed an emergency situation by farm/equine staff and every attempt to contact you has failed.
12. A student may be ordered to remove horses from the College farm if:
 - a. animals are not cared for properly
 - b. safety clothing is not worn when riding
 - c. any person is found riding horses without permission from Hostel Supervisors
 - d. an animal causes problems, e.g. Repeatedly escaping from horse paddock, poor temperament
 - e. students do not maintain safe and responsible riding practises
 - f. there is any danger of infecting other farm animals
 - g. stables and equipment are not kept in a clean and safe manner
13. This document should be read in conjunction with the conditions contained within the documents titled Horse Sign-Off Sheet and Horse Riding Policy.
14. Horse riding is not permitted around the Administration and shed areas.
